Sub: Instructions on Austerity Measures – Clarification thereof

Reference is made to this office letter of even number dated 29.06.2009 and 02.07.2009 wherein it was decided to curtail certain incentives/ allowances/ facilities etc. as austerity measures.

2. It is clarified as follows:

- (i) The expenditure on account of OPA for executives and incentive package for performing extra duties admissible to ATC & Comm. Discipline is reduced by 50% in terms of total expenditure and it will be regulated/monitored by the concerned REDs/APDs/Concerned HOD/ In charges. (Ref. para 1 (V) of Order dated 29.06.2009.)
- (ii) The executives holding the Scale of Pay of Rs. 29100-54500 (i.e. Sr. Manager) and below who are entitled to travel by air, are allowed to perform journey by train in the entitled class (Ref. para 1 (i) of order dated 02.07.2009) will be regulated as under:
 - a) The executives performing journey for Tour and Training – May avail journey by Train (Entitled Class) or by Air (Air India) whichever is cheaper. This will be applicable with immediate effect.
 - b) The executives performing journey on Transfer – May avail the same as per their entitled Class upto 31.8.2009 however on or after 1.9.2009 they will be entitled to travel by Rail (entitled Class) only.
- (iii) Considering the difficulties faced by the employees posted at North-East Region, Port Blair, Agatti and Srinagar, due to non availability of road/railway transportation system etc. may continue to perform journey by air (economy class) on tour, transfer and L.T.C. as per the existing orders. However, there is no change in the hub-stations.
