Sub: AAI (Employees Medical Attendance and Treatment) Regulations 2003 - Conditions for Dependency.

Please refer to clause 3(1) of AAI employees (Employees Medical Attendance and Treatment) Regulations 2003, wherein the condition of dependency is defined as 'a Member of the family whose total income from all sources including Pension, temporary increase on pension or stipend etc does not exceed Rs. 1500/- p.m.' In this context, clarifications have been sought whether disabled/spastic children suffering from incurable diseases with more than 60% disability/deformity irrespective of the age, are included as dependent in the definition of the family of the serving employee as in the case of retired employees.

- 2. In the above context, it is clarified that the medical facility is applicable to the disabled/spastic children suffering from incurable disease with more than 60% of deformity/disability as dependents of the serving employee irrespective of the age limit, provided such dependent children should not have income more than Rs. 1500/- p.m. from all sources, and are living with the employee.
- 3. It is further clarified with reference to the provision contained in clause 3.1.5 of the AAI (Retired Employees) Medical Benefit Scheme as circulated vide letter dated 16.06.2008 that the condition of income as defined in para 1 above, is also applicable in respect of the disabled/spastic children of the retired employee with more than 60% deformity/disability.
- 4. This issues with the approval of the Competent Authority.
