SUB: LEASED ACCOMMODATION AND RECOVERY THEREOF - POLICY

Reference is made to this office letters No. D-11029/SL/2/90-P&C dated 9.3.1992, No. PERS-I/1004/3/86 dated 27th July, 1995, D.11011/1/96-PP dated 27/9/96 and dated 07/1/97 wherein lease facility is available to all executives including operational category staff.

- 2. It has been decided to review / modify the existing lease facility applicable to all executives including Jr. Executives as under:-
- For the purpose of Lease entitlement, the classification of cities will be the same as applicable for HRA (i.e. X, Y & Z class cities).
- (1) The details of Revised Lease entitlement in each scale is as under :-

- (iii) The self-lease / company lease is permissible only in the event of non-availability of entitled accommodation in AAI township.
- (iv) Rates notified for Delhi-NCR by the Municipal Corporation for the leased accommodation will be applicable. The area wise rental rates for other locations will be decided by respective REDs. In any case overall lease entitlement will be restricted to the ceiling.
- The deduction of License fee will be at the rate of 10% of Basic Pay.
- 4. The Management will have discretion to turn down the request of officials for leased accommodation, if it is felt necessary that particular category of officials are required to stay in the Authority's colony for operational reasons.
- The lease entitlement permissible for those NE-9 level employees as per earlier instructions and its recovery will be decided on implementation of revised Pay Scales for workmen.
- 6. Other Terms & Conditions shall remain unaltered.
- This issues with the approval of the Competent Authority.
