**Sub : Revision of Scales of Pay of Board level and below board level Executives and non-unionised Supervisors in Airports Authority of India.**


Sir,

I am directed to refer to your letter No.A-60011/77/2008-PP dated 27<sup>th</sup> April, 2009 on the subject cited above and to say that in exercise of powers conferred by sub-section 1 and 2 of section 40 of the Airports Authority of India Act, 1994 (No.55 of 1994), the President is pleased to direct Airports Authority of India to implement revision of pay and allowances of Board level, below Board level executives and non-unionised Supervisors in AAI strictly as per the guidelines contained in DPE OM No.2(70)/08-DPE(WC) dated 26.11.2008, No.2(70)/08-DPE (WC)-GL-IV/09 dated 9.2.2009, No.2(70)/08-DPE(WC)-GL-VII/09 dated 2.4.2009 and No.2(76)/08-DPE (WC)-GL-VIII/09 dated 2.4.2009. A copy of each of the OM is enclosed. Special attention is invited to para 2(ii) of DPE's OM No.2(70)/08- DPE(WC) dated 26.11.2008 and para 4 of OM No.2(76)/08-DPE(WC) dated 2.4.2009.

2. It must be ensured that there are no aberrations from DPE guidelines during the implementation of present pay revision. For any deviation, the proposal with justification must be referred to this Ministry for taking up the matter with DPE. Proposals regarding existing scales which do not have the specific approval of the DPE may be sent to the Ministry. Further, for the purposes of fitment benefit, if any, extra ordinary increment(s)/and/or increase in the pay in respect of executives/non-unionised supervisors have been granted with retrospective effect which affects the revision of pay as on 1.1.2007 and which does not have the approval of DPE, such increment and/or increase in pay will be ignored for the purpose of fitment/pay revision.

3. This issues with the concurrence of JS&FA, MOCA vide Diary No.8498 F-I dated 01-05-09.
