Sub: Proficiency scheme for CNS Executives - Change in Eligibility Criteria

Sir,

1. Proficiency scheme for CNS executives was issued vide CHQ letter No. A.60011/45/2004-PP Dated 30/01/2006. With a view to meet regulatory requirement as mentioned in DGCA CAR for deploying trained manpower for operation and maintenance of CNS/ATM Automation systems, Eligibility Criteria, prescribed in Para 4 of aforementioned Proficiency Scheme has been reviewed.

2. Revised eligibility criteria is as mentioned below:-

Existing Para 4- Eligibility Criteria:-

"Executives of CNS discipline in the cadre of Technical, Communication & Electronics up to the rank of General Managers are eligible to draw the proficiency allowance. The proficiencies in various facilities can be taken only in a sequential manner. An executive becomes eligible to appear in proficiency examination of group only after she/he becomes proficient in all the facilities of the previous group as per the flow chart attached as (Annexure-I). Six groups have been identified for this purpose....."


Revised Para 4- Eligibility Criteria:-

"Executives of CNS discipline in the cadre of Technical, Communication & Electronics up to the rank of General Managers are eligible to draw the proficiency allowance. An executive shall be eligible to appear for proficiency examination on a facility in any of the groups and shall be eligible to draw proficiency allowance as and when he/she acquires proficiency on the equipment/facility on operational need basis. Six groups have been identified for this purpose....."

3. Rest of the content of Para 4 and Other Terms and conditions of the proficiency scheme remains unchanged.

4. - The above change in the eligibility criteria will be applicable w.e.f 01/08/2012. Executives, who have acquired proficiency on facility/equipments, earlier, shall also be eligible to draw proficiency allowance w.e.f 01/08/2012.

This issues with the approval of the competent authority.
