The Promotions being ordered are provisional and are subject to review on the basis of decision of the AAI on the recommendations of the inter-se-seniority committee.

All the promotees may be specifically intimated that the Promotion is subject to the decision of Hon'ble High Court of Delhi in WP(C) No.7390/2001.

They will be under probation for a period of one year from the date of joining.
